1. The Koshi Province Government has allocated funds to cover eligible payment under the Contract for the Procurement of Ice-Lined Refrigerator (ILR) (IFB No: DoLFD/G/NCB/01/082/83). Bidding is open to all eligible Nepalese Bidders.
2. The **Directorate of Livestock and Fisheries Development, Koshi Province, Biratnagar** invites electronic bids from eligible bidders for the procurement of **Ice-Lined Refrigerator (ILR)** under National competitive bidding – Single Stage Single Envelope procedures.
3. Eligible Bidders may obtain further information and inspect the bidding documents at the office of **Directorate of Livestock and Fisheries Development, Koshi Province, Biratnagar-10, Morang** or may visit PPMO egp system [www.bolpatra.gov.np/epg](http://www.bolpatra.gov.np/epg).
4. Bids must be submitted electronically through e-GP of PPMO website [www.bolpatra.gov.np/epg](http://www.bolpatra.gov.np/epg). The bidders shall pay on non-refundable fee of NRs. 3000 (in words: Three Thousand only) for the bidding document via. following account and shall upload the scanned copy (pdf format) of the Bank deposit voucher at the time of electronic submission of the bid.

5. Pre-bid meeting shall be held at **Directorate of Livestock and Fisheries Development, Koshi Province, Biratnagar** on 27<sup>th</sup> February, 2026 (15<sup>th</sup> Falgun, 2082) at 13:00 hours.



6. The electronic bids must be submitted to the office through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 11<sup>th</sup> March, 2026 (27<sup>th</sup> Falgun, 2082) at 12:00 hours. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on 11<sup>th</sup> March, 2026 (27<sup>th</sup> Falgun, 2082) at the office of **Directorate of Livestock and Fisheries Development, Koshi Province, Biratnagar**.
8. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, amounting to a minimum of NRs. **4,50,000 (Four lakhs and Fifty thousand only)**, which shall be valid for 30 days beyond the validity period of the bid i.e. 11<sup>th</sup> July, 2026 (27<sup>th</sup> Ashad, 2083).
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the **bid** and **bid security** shall remain the same as specified for the original last date of bid submission.
10. Bids should comply in all respects with Instructions to Bidder included in the Bid Document. Non-compliance with this instruction shall result in disqualification.
11. Matters not covered by this notice shall be in accordance with Public Procurement Act, 2063 and Public Procurement Regulation, 2064 and other prevailing rules and regulations.
